# Monetary gains and activities

Public funding, in the form of grants, is allocated to businesses for the execution of research projects specifically, research development within the enterprises.

The duration for each research application is a maximum of 36 months, no later than June 30, 2029.

- Maximum research application amount: 192,360 EUR
- An initial evaluation, a mid-term evaluation, and a final evaluation are conducted for each research application. There is no mid-term evaluation for applications with a duration of less than 12 months.





Compensation expenses for a postdoctoral researcher

In alignment with the company's compensation policy (*no rate limit* established, but must be incorporated in the application amount)

Covers expenses associated with research, including the protection of technology rights and outsourcing, such as laboratory services.



### Competence enhancement and mobility

Funding for training events, networking opportunities, and international mobility that promote research collaboration. **Mobility is not mandatory for enterprises.** 

# Publication and participation in conferences

Research expenditures

Expenses associated with the publication of scientific articles and participation in conferences for the dissemination of research findings.

#### Main conditions for entrepreneurs

*for research application related to economic activity* 

#### Enterprise rights and obligations

Applicants can be small (micro), small, medium or large entrepreneurs registered in the Register of Enterprises of the Republic of Latvia. They must provide postdoctoral researcher with access to the necessary infrastructure, materials and human resources to carry out their research projects.

#### Financial stability and economic performance

The enterprise must not possess any active recovery orders and must not be experiencing financial difficulties (as evaluated by undertaking in difficulty). These requirements are also assessed in the case of de minimis aid.

#### Intensity and categories of financing

- Funding is allocated as grants, in compliance with EU regulations: 2023/2831 de minimis aid conditions or 651/2014 regulation conditions.
- De minimis aid is provided with limitations concerning the sectors in which the merchant engages.
- For projects associated with economic activity, the maximum support intensity for industrial research may vary between 50% and 80%, depending on the size of the enterprise and the public accessibility of the project results.



#### Assistance intensity

Fundamental Intensity of up to 85% of eligible expenses research

Industrial For micro and small enterprises - 70% of the expenses For research medium-sized enterprises - 60% of the expenses For large enterprises - 50% of the expenses

Intensity increase – in specific instances, the intensity of public funding for industrial research may be augmented by 15 percentage points if the project results are made publicly accessible, such as being published in open databases or presented at scientific conferences. The support intensity must not surpass 80%.
