# PostDoc 1.1.1.9. "Postdoctoral Research" Latvia



Project implementation: 17.06.2024-31.12.2029.

**Program funding for research applications: EUR 39 million.** 

ERDF – EUR 33.187 million. State budget co-financing – EUR 4.286 million. private co-financing – EUR 1.527 million.

### 2021. – 2027. planning period Activity L.9. "Postdoctoral Research"

### **Purpose of the Activity 1.1.1.9.**

# First round of selection 08.08.2024. - 07.10.2024 at 17.00



#### **Research applications not related to economic activity**

In the first round of selection, only research applications not related to economic activity can be supported.

#### The available total eligible financing is EUR 17,000,000

For the implementation of industrial and fundamental research applications.

#### EUR 3,400,000 for fundamental research

Funding available for the implementation of fundamental research applications is 20% of the total funding of the first round of selection.

#### **Submitter - Scientific institution**

A research application can be submitted by a scientific institution registered in the Register of Scientific Institutions of the Republic of Latvia, which complies with Commission Regulation no. 651/2014 for the definition of research and knowledge dissemination organization set out in Article 2, paragraph 83.

#### **Start of implementation January - June 2025**

Implementation of applications must be started within 6 months from the moment of receiving the approval.

# Who can submit and implement a research application?

### **Scientific institutions**

Submitted by: a scientific institution registered in the Register of Scientific Institutions of the Republic of Latvia, which meets the definition of a research organization and plans to implement applications not related to economic activity.

# A post-doctoral researcher is employed at the scientific institution

Implemented by: a Latvian or foreign scientist who obtained a doctorate no more than 10 years before the deadline for submitting the research application and, while implementing the research application, is employed full-time at the scientific institution.

### **Conditions for research applications**



#### **RIS3 +** interdisciplinary research

The study must comply with RIS3: 1. Knowledge-intensive bioeconomy; 2. Biomedicine, medical technologies, biopharmaceutics and biotechnology; 3. Smart materials, technologies and engineering systems; 4. Smart energy and mobility;

5. Information and communication technologies.



**Available** financing EUR 191,700

The maximum allowable total eligible funding for one research application is EUR 191,700.



Implementation period 36 months

The maximum implementation period is 36 months, but no longer than until June 30, 2029



#### **ERDF** funding 85%

For research applications, the maximum eligible ERDF funding is 85%.

Co-financing of 15% is provided by: - from the state budget funding - no more than 10%; - the rest of the other funds at the possession of the research organization.

### **Research application cost items**

#### The costs of the research application include the following eligible cost items of the research application:



Compensation costs per year do not exceed EUR 46,320, incl. mandatory state social insurance contributions and other social guarantees. Compensation for full time.

**Administrative** costs of one unit **255 EUR** 

The applicant's administrative and infrastructure costs include: stationery, office supplies, room rental, utility payments, infrastructure equipment, internet costs, laboratory equipment, information technology maintenance, support and management personnel compensation costs (Article 62.3 of the MK).



#### The cost of one research unit is 1000 **EUR**

Research costs include the costs of purchasing materials necessary for research, protection of technology rights and outsourcing. Also includes: publication costs, training costs, costs of networking events (business trips, conference participation fees and costs of involvement in informative events).

#### **Mobility and family allowance** costs


If the duration of the mobility is at least six continuous months or more, the following shall be granted:

- 600 euros per month for a postdoctoral researcher:
- 660 euros per month family allowance.

#### **Relocation allowance - a one-time allowance**

A one-time allowance of EUR 600 can be paid to cover the expenses of the postdoctoral researcher moving to Latvia and an additional one-time family allowance of EUR 660.

### **Results of research applications**



A research workplace has been created in the supported structures

Number of scientific articles

Number of new products and technologies that are commercializable

A position of a new researcher or leading researcher has been created for the post-doctoral researcher in the structural unit. I year sustainability must be ensured.

Articles published in Web of Science or Scopus databases. Articles accepted for publication are also counted. At least 1 scientific article must be prepared.

New product (goods or services that are completely new or have improved functional characteristics or changed intended use) and technology. Patent, prototype, technology description.

Private investments supplementing public support

Submit documents certifying that the percentage cofinancing part of the economic activity specified in the contract has been credited to the research application account

Number of companies cooperating with research organizations Research organizations participating in joint research projects

A cooperation partner agreement is concluded between the scientific institution and the entrepreneur, if the research application is implemented by the scientific institution in partnership with the entrepreneur or uses its infrastructure.

A cooperation agreement is concluded between two research organizations if the research application is implemented in partnership or uses the organization's infrastructure.

### Mobility

 $-\int_{-}^{+}$  Is mobility a must? Yes, two months of mobility is mandatory - it is possible to divide it into several stages in different destinations.

Long mobility 6 months. and more by choice - cannot be divided into stages, with one mobility partner, it is additionally possible to receive funding to cover mobility costs and a family allowance.

### **Publicity**

Are publicity measures mandatory?

**Mandatory measures:** 

- Information must be published on the website at least once every 6 months;
  There must be a poster about the implementation of the research application in a publicly accessible place;
- When disseminating the results, a reference to the research application (application number, title) should be given.

### Activities not supported in the research application:

- development of study courses and teaching materials, lectures,
- $\circ\,$  development of a separate website intended only for the research application,
- development of new, separate IT systems or databases that are not related to or based on research.

#### **Can I work elsewhere?**

A post-doctoral researcher can work elsewhere in parallel with the work at the institution, observing the requirements of the DL regarding the employee's workload and remuneration - in the same institution, if he works more than 1 full time - overtime must be paid. If you work at another institution, then we invite you to work no more than 0.2 hours, so that the quality of the postdoctoral research does not suffer and all the work assignments are completed on time.

## Submitting a research application

### The documentation is available at lzp.gov.lv

The regulations for the first round of selection of research applications with attachments are available on the LZP website in the section Postdoctoral program - Competitions 1.1.1.9.

### **Registration in PostDoc IS**

The institution must conclude a contract with LZP for the use of PostDoc IS and obtain access to the system.

Applications are submitted using PostDoc IS. Information is provided in Latvian.




